This supplement (the "Supplement") to the base prospectus dated 11 April 2024, as supplemented on 31 July 2024 and on 23 January 2025 (the "Base Prospectus") constitutes a supplement for the purposes of Article 23 of Regulation (EU) 2017/1129 (the "Prospectus Regulation") and is prepared in connection with the programme for the issuance of debt instruments (the "Programme") established by Telefónica Emisiones, S.A.U. (the "Issuer"). Terms defined in the Base Prospectus have the same meaning when used in this Supplement.

This Supplement has been approved by the Central Bank of Ireland (the "Central Bank") as competent authority under Regulation (EU) 2017/1129. The Central Bank only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by Regulation (EU) 2017/1129. Such approval should not be considered as an endorsement of the Issuer or the Guarantor that is the subject of this Supplement nor as an endorsement of the quality of any Instruments that are the subject of the Base Prospectus. Investors should make their own assessment as to the suitability of investing in such Instruments.

The purpose of this Supplement is to incorporate by reference into the Base Prospectus Telefónica's Annual Financial Report for the year ended 31 December 2024.

This Supplement is supplemental to and should be read in conjunction with the Base Prospectus and any other supplements to the Base Prospectus issued by the Issuer.
