The platform automates tasks such as generating quotes, validating data, and renewing policies, which not only streamlines the work of professionals in the sector, but also improves accuracy and reduces human errors.

We are excited to bring intelligent automation to more brokers across Europe, helping them modernize their operations without disrupting what already works for them."
